The following is the local educational agency's (LEA's) plan for providing supplemental instruction and support to students, including those identified as needing academic, social-emotional, and other supports, including the provision of meals and snacks. ## **Plan Descriptions**

A description of how parents, teachers, and school staff were involved in the development of the plan.

Each month, the entire Crete team, which includes administrators, teachers and support staff meet to discuss student academic progress. During the review, assessment data is reviewed and discussed. Other data points such as attendance and wellness data are discussed to determine the priorities for the next 30 days. The staff then breaks into groups to determine what the focus should be and what goals should be set for the school. Every 30 days this process is initiated again.

Parents were engaged during Mama's Meet-Up and Men of Crete, as well as daily onsite during drop-off and pick-up. During these times school administrators and teachers discussed individual and school wide student needs. Information from these conversations was brought to the school administrators and incorporated into this plan.

A description of how students will be identified and the needs of students will be assessed.

The student groups for which this plan was developed include: low-income students, English Learners, students in foster care, students experiencing homelessness and students with disabilities. Student participants were identified using state and school wide assessment data, individual teacher recommendations and parent request. In particular, to determine the students that would participate in summer programming, we issued a survey to gauge parent interest. Based on the results of the survey, which included student information and academic content area of interest. The survey data was then used to formulate the 2021 summer program.

Crete communication is strong and will be maintained to inform parents of the additional opportunities for supplemental instruction and support. Weekly, we will continue to issue school wide text messages with all upcoming events and necessary information. ClassDojo, which is the app that is used by 100% of families and staff at Crete, will also provide weekly and daily event communication, available programs and necessary information. Monthly calendars will continue through the summer for families participating in summer school and will continue through the 2021-22 school year. Finally, school information regarding opportunities for supplemental instruction and support and other pertinent school information is always available on our school website at: www.creteacademy.org.

A description of the LEA's plan to provide supplemental instruction and support.

Crete's plan to provide supplemental instruction and support can be summarized into three parts: Intervention, Additional Instruction and Enhanced Programming.

Intervention will be provided, as it was during the 2020-21 school year, through Teaching Fellows. Students will be able to access tutoring by parent or teacher request daily and weekly. Teaching fellows will also provide in-class and out-of-class intervention in ELA and math in homogenous small groups, at the discretion and request of teachers or parents. Lastly, Teaching Fellows, will provide tutoring 1:1 to any student or parent who requests such support.

Additional Instruction will be provided through Summer School Programming. The Crete Summer Program will be provided to Crete students who sign up for the 2021 summer period. Daily instruction for a period of four weeks will include ELA, Math and enrichment programming. All students wishing to participate in summer school will be allowed entry to the program.

The final aspect of Crete's supplemental instruction and support plan is Enhanced Programming, which includes a structured after school program for the 2021-22 school year. Crete's after school program will include tutoring, homework support, small group teaching and enrichment programming for the entire 2021-22 school year.

By providing these three types of support services, we will address the learning loss with our focus student group.

A description of how ELO Grant funds are being coordinated with other federal Elementary and Secondary School Emergency Relief Funds received by the LEA.

ELO funds will be used to supplement the existing tutoring, intervention and after school programming. In addition to the existing program support, ELO funds will be used to provide summer school to 35 students in grades 1-5 for the 2021 summer period. Upon returning to school in the fall of 2021, students will have access to high-quality tutors, both 1:1 and small group, daily intervention groups in and out of the classroom and after school programming. These collective efforts are designed to mitigate learning loss and support future learning at Crete Academy.

## **Expanded Learning Opportunities Grant Plan Instructions: Introduction**

An LEA receiving ELO Grant funds under *EC* Section 43521(b) is required to implement a learning recovery program that, at a minimum, provides supplemental instruction, support for social and emotional well-being, and, to the maximum extent permissible under the guidelines of the United States Department of Agriculture, meals and snacks to, at a minimum, students who are included in one or more of the following groups:

- low-income,
- English learners,
- foster youth,
- homeless students.
- students with disabilities,
- students at risk of abuse, neglect, or exploitation,
- disengaged students, and
- students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

#### For purposes of this requirement

 "Supplemental instruction" means the instructional programs provided in addition to and complementary to the LEAs regular instructional programs, including services provided in accordance with an individualized education program (IEP).

- "Support" means interventions provided as a supplement to those regularly provided by the LEA, including services provided in
  accordance with an IEP, that are designed to meet students' needs for behavioral, social, emotional, and other integrated student
  supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.
- "Students at risk of abuse, neglect, or exploitation" means students who are identified as being at risk of abuse, neglect, or exploitation in a written referral from a legal, medical, or social service agency, or emergency shelter.

EC Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies being provided (EC Section 43522[h]).

The seven supplemental instruction and support strategies are:

- 1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
- 2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
  - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
  - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.
  - c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
- 3. Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
- 4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
- 5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students' college eligibility.
- 6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.

7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students' social-emotional health needs and academic needs.

As a reminder, *EC* Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

#### **Fiscal Requirements**

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals to provide supplemental instruction and support through the duration of this program, with a priority for full-time paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.
- An LEA may use up to 15 percent (15%) of its apportionment to increase or improve services for students participating in distance learning or to support activities intended to prepare the LEA for in-person instruction, before in-person instructional services are offered.
